

CCKC Board Minutes

July 11, 2022

CALL TO ORDER:

The meeting, was called to order at 7:00p.m. by President, Paul Coleman, at the main clubhouse on July 11, 2022.

MINUTES JUNE 21, 2022:

Motion to accept the June Minutes was made by Scott Jackson, Second by Dan Christiansen. Motion passes.

TREASURER: Susan D'Aloia – For all HRO's, there has been incorrect information received, such as, deposit slips were unclear and mixed-up. As a reminder: please circle what range it is and indicate which range it is on the deposit slips.

Income is up a bit. Net income looks strong at \$37K+. There is a lot of depreciation. Current projected depreciation is \$74K for CCKC as a whole. Improvements: Shotgun: \$88K, Clubhouse \$48K.

Paul Coleman: We need to upgrade our ranges to keep them up and running and to be competitive in the market.

RANGE REPORTS:

Airgun: Alex Modic – Mosquitos are not present, that's a good thing. We had a report of a ricochet on Saturday, July 9, 2022 between the approximate time of 1:00 and 3:00p.m. Had to have been a cross-fire. Reminder on rifle range cross-fire is important for RO's to identify. I do not have a report yet. I'll investigate and report back. I'm meeting with the guy who heard the ricochet. My RO was not present at that time.

I put up a sign indicating the price increase for memberships, but I told my clients that there will not be an increase for the airgun range.

Archery: Joe – We're completing a major cleanup. We will be starting work on seven (7) targets on the other side of the bridge. Water is low and has been for last month. No

activity on beaver dam. We are seeing an uptick on shooters. We have received positive feedback on the canopies.

Barb: - Youth Night was a success. We had 7-10 shooters. Our next youth night is July 29 at \$5.00/archer. We are discussing increasing league fees. Spring League dinner is July 27. We are seeing an uptick of archers on Sundays. We are getting new memberships because of the Facebook advertising. Also, two (2) local archery shops are advertising our youth night.

Rifle: Bob Tollman – We saw a busy weekend. Both Saturday and Sunday. A few people negatively commented on the increase but overall, we've had positive feedback. The roof, trim work and lights are complete. The water leakage issue has been addressed. The tank was sealed. We are installing automatic stop on faucets and urinals.

Shotgun: Bill Lerch – We are up 40% versus year ago mostly driven by the Falcons tournament that was held on June 4 and 5, 2022. Falcons are finished until Spring. However, we are discussing a Youth Fall League. Pursuing events to increase income. Our 5-Stand League has been running smoothly. We will continue with the 5-Stand League for Fall beginning in September.

Today skeet range poles were erected. Shot curtain on its way tomorrow. By next week shot curtain will be complete. We have had positive feedback on the shot curtain, especially people who are vision handicapped. They are able to see the clays clearer. After the shot curtain is erected on the skeet field, we can go from 9's to 8's, which, hopefully will increase shooters. We have received positive feedback on the environmental impact from the projected lead recovery.

Black Powder: Dan Christiansen – I haven't been around the past two (2) weeks. Fairly good over the weekend. About \$140.00. Had a few RO's complain about the increase. Saw three (3) new faces on the range. And saw some past faces that we've haven't seen in a while. Still don't know what happened with the gun blow-up.

Need okay from the board to purchase a chain saw. Two (2) people will have access to it. It will be locked up. Dan or Fred will take responsibility for the saw.

Also, someone uncased a gun before 9:00. Another person saw it and RO handled the situation.

May have to supply NRA certified muzzle loader instructors for our Civil War shoots. There will be campers Friday and Saturday. We had about 50 shooters for our Civil War skirmish on July 16 & 17.

Motion by Dan Christiansen to purchase chain saw not to exceed \$350.00 for the Wilderness Range. Second by Dennis Cronin, Motion Passes.

Cowboy Range: We had a shoot this past weekend. Saturday, we had six (6) and Sunday we have twenty-three (23). Everything went well. Gravel is down. I weed-whacked so that the shooters can pick up their brass.

Correspondence/Old Business: President, Paul Coleman – Please review 2022 President's Summary and let me know if you have any questions, comments, concerns.

Lawn Service: About 3 hrs./week, the service skipped it once. We will negotiate the \$7,500.00 with trimming all ranges.

Motion by Alex Modic to pay the \$7,500 to include trimming of all ranges, at least monthly, and finish out the season then reinvestigate other companies for the 2023 season. Second by Scott Jackson, Motion passes.

Bristol Woods called saying a CCKC tree fell over their property and kids can get hurt. When Paul investigated the situation, the tree was on the ground and no longer an issue. Paul will call the Bristol homeowners Assoc. and let warn them about the dangers of trespassing on an active archery range.

Paul will investigate whether or not deer hunting is happening on CCKC property..

New Business: Joe is requesting anyone with "used" archery equipment to please consider giving to the archery so we may have equipment for people to use.

Motion to adjourn by Alex Modic at 8:40p.m. Second by Jerry Lis. Motion passes.
